**GENERAL FILING INSTRUCTIONS
FOR
NOTICE OF WINDING UP AND ARTICLES OF TERMINATION
(Pursuant to ARS §§ 29-781 & 29-783)**

1. Deliver the completed **original Notice of Winding Up and Articles of Termination and (one (1) or more exact copies)** to the Commission. Your filed copy will be returned to you when all requirements have been satisfied. **Notarization is not required.**
2. The Notice of Winding Up and Articles of Termination must be executed by a manager, if management of the limited liability company is vested in a manager, or by a member if management is reserved by the members.
3. **Pay the required (U.S). fees.** Please make check payable to the Arizona Corporation Commission. Expedited service is available for an additional \$35.00 fee.

4. If the person executing the documents has a power of attorney authorizing him/her to do so, a copy of the document granting authority must be included with the filing.
